1. Updates from building committees on implementation of Shared Decision Making (SDM)
 - Each building shared what the building level teams are working on. Information that was shared included positive impacts of students being involved on the committees. Additionally, each school was working on issues that were brought up at their SDM meetings.
2. Review of District Shared Decision Making Plan
 - We discussed a few aspects of the plan such as issues subject to shared decision making and consensus. Additionally, the team discussed school safety and what the district is doing and how students feel about their personal safety.
3. ESSA designations and required District Comprehensive Improvement Plan (DCIP)
 - Mary-Margaret shared information regarding the new NYSED designations. She shared that the District was identified as a Targeted District and North Broad Elementary School was identified as Comprehensive Support and Improvement building (CSI). She shared that the identifications are based on student performance and growth on NYS 3-8 assessments, the number of students participating in the NYS 3-8 assessments, chronic absenteeism, graduation rate, and college and career readiness. Furthermore, she stressed that the district has a low number of students participating in the NYS 3-8 assessments which directly impacts the identifications. Lastly, she shared that that the identifications will provide an opportunity to grow and learn. We will be following NYSED guidelines for CSI schools and Targeted districts.
 - Mary-Margaret shared that the district will be required to complete a District Comprehensive Improvement Plan (DCIP) sometime this spring. Guidance on specifics are still pending from NYSED.
